Note: Water, tea, lemonade, soft drinks and sports drinks will **ONLY BE SOLD** by Cherokee Pignic.

You will be required to complete and return a 'no cost' temporary food permit application that will be sent to you after your concessionaire application is accepted.

- **No rain date or refunds due to rain or any other weather situations.**
- Concessionaire agrees to have booth set-up and ready by 3 p.m. on Friday and 1/2 hour before festival opening hours on Saturday.
- The booth may **NOT** be dismantled before 6 p.m. on Saturday. (**Absolutely no early breakdown allowed**).
- One car or truck per applicant will be permitted. Said vehicle must be parked in concessionaire parking area.
- All concessionaires will decorate their booth so as to provide an attractive and clean appearance.
- Concessionaires agree to sell only those items approved by Cherokee Pignic organizers.
- Each concessionaire will receive a letter listing the approved items.

In consideration of your accepting this application, I the undersigned, intending to be legally bound, hereby, for myself, my heirs, executors and administrators, waive and release any and all rights and claims for damages I may have against the Cherokee Pignic organizers, the Cherokee County Chamber of Commerce and the City of Canton, their representatives, successors, and assigns for any and all injuries suffered by me in this event. Further, I hereby grant full permission to the Cherokee Pignic organizers or authorized agents to use any photographs, videos, recordings or any other record of this event for any legitimate purpose.
